PROPOSED AMENDMENT TO THE C&C 27 CLASS ASSOCIATION CONSTITUTION

The C&C 27 Class Association was started in 1980 in the Toronto area to promote Level racing between the Mk's 1-4 and to try and keep the boats as stock as possible, so as to hopefully keep value in these owner's boats.

When the Mk 5's were developed in 1984, the Association deemed that due to the complete difference in hull, keel, rudder, displacement and sail area that it would be impractical to have Level racing with these boats included.

The present Directors of the Class Association still believe it is not practical to have fair Level racing with the Mk 5's. The boats have been placed in the same start at regattas over the years with the PHRF scoring system in place. This has clearly shown that the Mk's1-2 don't have a chance to compete when analyzed on a boat for boat finish and in fact the Mk 3-4's can only compete in a certain wind range with the Mk5's on the same basis. But, having the various Mk's start together under PHRF at these regattas has not only ensured our own start sequence but given all of us better racing and more credibility at these events. It has been commonly said that we would rather compete against each other under handicapping rather than compete against other designs.

The Class Association has recognized Mk 5 Owner's for a number of years as members of the Association and would now like to embrace these members and their boats by including the Mark V and it's original specifications in the Class Constitution.

The Class's website has clearly shown a need for a common thread amongst the Mk 5 Owner's. We feel that by including them officially we will all be stronger financially to carry on the website for all Mk's Owners and to also have a heavier voice within the sailing community where required with respect to our boats in the future.

The present Board of Directors does not feel that the inclusion of the Mark V will not undermine the original intent of the founding members of the Association but only help to maintain the spirit of the design, character and integrity of the C&C 27 Sloop as designed by C&C Yachts while maintaining fair competition within the Fleet and maintaining the highest possible values for our boats.

We the Five Active Members below propose the attached Amended Constitution:
